Global Fusion Music & Arts (hereafter known as GFMA) membership is open to anyone, provided that they adhere to all of the GFMA policies and practices, including GFMA's Objects, Equal Opportunities and Health Safety Policies.

Members Contributions

- There is an annual contribution of £22, which should be paid at the beginning of each financial year (6th April), payable to Global Fusion Music & Arts, by BACS, cheque or cash, Or paid in monthly affordable instalments. This fee will be reviewed annually.
- As a charitable organisation, GFMA would appreciate any member who can contribute both the fee and voluntary assistance or help.
- Any eligible members are invited to complete a Gift Aid declaration for GFMA, which, with members' permission, will be able to claim 25% Gift Aid for the organisation

Members Benefits

1. GFMA will consider members when selecting artists for work in schools and performances. A fee of 10 percent will be deducted from the fee charged to any third party unless the fee is less than £100, in which case no fee is charged. If a non-member is selected, then a fee of 15 percent of the fee charged to any third party will be deducted.
2. GFMA will endeavour to promote the artistic talents of its members.
3. Members have access to the recording, filming and editing facilities as well as training, at the discretion of the Chief Executive Officer on behalf of the Trustees.
4. Free entry is available to members who volunteer at events. All voluntary help must be pre -arranged with the Chief Executive Officer or the Front of House Manager.
5. Members can be actively involved in the development of the organisation if they attend the general meetings of GFMA. If a member would like to contribute an idea outside of the meetings, they should approach the Chief Executive Officer. .
